The City of Brookings ordains as follows:

Section 1. Ordinance Identified. This ordinance amends Ordinance No. 06-O-572, Brookings Municipal Code (BMC).

Section 2. Section 13.05.006 is amended to read as follows:

13.05.006 Penalty.

Pursuant to Chapter 1.05.

Section 3. Section 13.05.220 is amended to read as follows:

13.05.220 Access to property.

All duly appointed employees of the city, under the direction of the city manager, shall have free access at all reasonable hours of the day to any and all parts of structures and premises in which water is or may be delivered or used for the purposes of inspecting connection, the conditions of conduits, appliances and fixtures, and the manner and extent in which the water is being used. The city does not, however, assume the duty of inspecting the customer’s line, plumbing, and equipment, and shall not be responsible therefor. [Ord. 88-O-432; Ord. 66-O-190 § 24.]

Water Meter Obstruction.

Overgrown shrubs, vines, plants or landscape materials shall not obstruct access to water meters for inspection, reading and testing.
