AN ORDINANCE VACATING A PORTION OF FIR STREET AND A PORTION OF AN ALLEY LOCATED WITHIN BLOCK 17 OF THE CITY OF BROOKINGS, AS SAID STREET AND ALLEY ARE SET FORTH AND DESCRIBED IN THE ADOPTED PLAN AND MAP OF THE STREETS AND ALLEYS OF THE CITY OF BROOKINGS, OREGON. [Effective November 9, 1954]

The City of Brookings ordains as follows:

Section 1. Proceedings for vacation of Fir Street and unnamed alley.
 The council, having made its own motion to vacate the hereinafter described portion of Fir Street and Alley, situated in Block 17 of the City of Brookings, and having directed the giving of notice required by law and having held the public hearing called for by said notice, finds, and hereby makes its determination a matter of record, that the proceedings for the vacation of said portion of said street and alley were had upon the council's own motion and upon petition of the Presbyterian Church of the City of Brookings and Palm M. Stout and C.A. McKenzie, who own property adjacent to and which shall be affected by the said vacation of said street and alley, and, further, that the public interest will not be prejudiced by the vacating of said portion of said street and alley; that the best interest and welfare of the public will be served by such vacation; and such vacation should be effected.

Section 2. Property description.

Section 4. Recordation. The City Engineer shall prepare a map and cause the same to be recorded with the City Recorder, showing thereon and setting forth therein, that portion of Fir Street and that portion of the unnamed alley hereby, in this ordinance, vacated.

Section 5. Exclusion from approved system of streets and alleys.
That portion of Fir Street and that portion of the unnamed alley in this ordinance vacated shall be excluded from teh approved system and plan of streets and alleys of the City of Brookings and from the official map thereof and the said map shall be amended to show said exclusion.
