**The City of Brookings ordains as follows:**

**WHEREAS, the City of Brookings has heretofore made an application to the State of Oregon, through its Highway Commission, for assistance in repair or reconstructing under the provisions of 366.800 and 366.805 ORS, and**

**WHEREAS, the State Highway Commission has accepted said application for the improvement of Pioneer Road from Pacific Avenue to Easy Street and Easy Street from Pioneer Road westerly for approximately 335 feet, a distance of 0.20 mile, and**

**WHEREAS, in the form of an agreement prepared by the State Highway Commission, a copy whereof marked "Exhibit A" is attached hereto and by this reference made a part hereof, the State Highway Commission has agreed to pay the cost of the project up to \$15,000.00 and the City of Brookings to pay all cost in excess of \$15,000.00 and**

**WHEREAS, it is necessary that said improvement be made in the Spring and Summer of 1956 and, to such effect, the State Highway Commission can now award a contract for said improvement until the aforesaid agreement "Exhibit A" has been executed by the City of Brookings, now therefore:**

**Section 1. Approval and acceptance of agreement.** The aforesaid agreement, attached hereto as Exhibit A, by and between the City of Brookings and the State of Oregon acting by and through its Highway Commission, is hereby approved and accepted as submitted and set forth in this Ordinance No. 56-O-087.

**Section 2. Execution of agreement.** The Mayor and Recorder are hereby authorized and directed to execute said agreement as set forth herein as Exhibit A in triplicate and after executing the same to deliver the same to the State Highway Commission of the State of Oregon for execution by said Commission.
