AN ORDINANCE DECLARING THE ANNEXATION OF CERTAIN PROPERTY TO THE CITY OF BROOKINGS. (Harris Beach Properties - Larry Anderson) [August 8, 1980]

Section 1. Declaration of Annexation.

Section 2. Submission to Secretary of State.

WHEREAS, LARRY ANDERSON, MARK ANDERSON and ANTHONY AFLAGUE have heretofore filed with the City Recorder of the City of Brookings their proposal for annexation of the real property hereinafter described to the City of Brookings; and

WHEREAS, by Ordinance No. 80-O-330 enacted on the 7th day of May, 1980, the City Council elected to dispense with submitting the question of annexation to the registered voters of the City of Brookings and fixed the 13th day of May, 1980, at 8:00 p.m. at the City Hall of said City as the time and place for public hearing upon such proposed annexation before the City Council of said City, at which time the registered voters of the City might appear and be heard upon the question, and order publication and notice of such hearing as required by law; and

WHEREAS, notice of such hearing was duly published once each week for two (2) successive weeks prior to the date of hearing in the Curry Coastal Pilot, a newspaper of general circulation in the City of Brookings, Curry County, Oregon, as more particularly appears from the proof of such publication heretofore filed with the City Recorder of said City, and

WHEREAS, said hearing has been duly held; and

WHEREAS, prior to said hearing the owners of all the land proposed for annexation filed with the City Recorder their consent in writing to such annexation;

NOW, THEREFORE, THE CITY OF BROOKINGS ORDAINS AS FOLLOWS:

Section 1. Declaration of Annexation. That the property described in Exhibit "A" attached hereto and by this reference made a part hereof, which said real property is situated in Curry County, Oregon and is contiguous to the City of Brookings be, and the same hereby is, annexed to the City of Brookings.

Section 2. Submission to Secretary of State. That the City Recorder be, and hereby is authorized and directed to make and submit to the Secretary of State a copy of this Ordinance, a copy of the statement of consent of all the land owners of said above real property heretofore filed with her, and a copy of said Ordinance No. 80-O-330 dispensing with the election within the City and ordering public hearing.
