

**ORDINANCE NO. 93-0-349.C**

**AN ORDINANCE AMENDING ORDINANCE NO. 81-O-349, SECTION 1 OF THE CITY OF BROOKINGS. [Effective February 23, 1993]**

**The city of Brookings ordains as follows:**

**Section 1. Ordinance Identified.** This ordinance amends Ordinance No. 81-O-349, enacted March 24, 1981, and entitled, "An ordinance adopting the State of Oregon Structural Specialty Code and Fire and Life Safety Code, the State of Oregon Mechanical Specialty Code and Mechanical Fire and Life Safety Code, and the Uniform Code for the Abatement of Dangerous Buildings, and repealing prior ordinances inconsistent therewith."

**Section 2. Amendment to Section 1, Subsection A.** Section 1, Subsection A of Ordinance No. 81-O-349 shall be amended by removing the wording "1988 edition of the Uniform Building Code", and replacing that wording with, "1991 edition of the Uniform Building Code based on the 1991 edition of the Uniform Building Code, except Chapter 3, Section 301(c) of the 1993 State of Oregon Structural Specialty Code."

**Section 3. Amendment to Section 1, Subsection B.** Section 1, Subsection B of Ordinance No. 81-O-349 shall be amended by removing the wording "1988 edition of the Uniform Mechanical Code", and replacing that wording with, "1991 edition of the Uniform Mechanical Code, based on the 1991 edition of the Uniform Mechanical Code".

**Section 4.            Amendment to Section 1, Subsection C.    Section 1, Subsection C of Ordinance No. 81-O-349 shall be amended by removing the wording "1988 edition of the Uniform Plumbing Code", and replacing that wording with, "1991 edition of the Uniform Plumbing Code, based on the 1991 edition of the Uniform Plumbing Code."**

**Section 5.            Amendment to Section 1, Subsection D.    Section 1, Subsection D of Ordinance No. 81-O-349 shall be amended by removing the wording "1990 Edition One and Two Family Dwelling Specialty Code", and replacing that wording with, "1991 Edition One and Two Family Dwelling Specialty Code".**

**Section 6.            Severability. If any provision, part or parts of this ordinance shall be held to be unconstitutional, invalid, or otherwise inoperative, such invalidity shall not affect other provisions hereof which can be given effect without the invalid provision, the remainder hereof shall remain in full force and effect as a valid and subsisting ordinance until repealed and to this end the provisions of this ordinance are declared to be severable.**
